- ✓ MEMBERS MUST BE ABLE TO PRODUCE MEMBERSHIP CARD OR MEMBER NUMBER UPON REQUEST
- ✓ NO LITTERING – PLEASE PICK UP DISCARDED TRASH
- ✓ NON-MEMBERS PLAYING MUST BE ABLE TO PRODUCE A PAID RECEIPT UPON REQUEST (other than events)
- ✓ EVERY MEMBER IS RESPONSIBLE FOR REPORTING VIOLATIONS TO BOARD MEMBERS
- ✓ ALL MEMBERS MUST SIGN IN AT CLUBHOUSE BEFORE PLAYING
- ✓ NO METAL SPIKES ALLOWED
- ✓ GROUPS LARGER THAN A FOURSOME SHALL IMMEDIATELY ALLOW PERSONS TO PLAY THROUGH IF THEY ARE ON THE TEE BOX OF THE SAME HOLE
- ✓ REPORT OBSERVED DAMAGES, WATER LEAKS, ETC
